Students met the standard of success for all outcomes and assessment tools. Lower scores occurred when students did not carefully follow rubric guidelines, assignment instructions or did not complete a project.

An additional assessment was added in the past two terms (since Spring 2022): a capstone project.

The number differs due to withdrawal or lack of completion of the course or assessment tool.

The course is offered only online. All students enrolled in online sections during all terms included in the assessment.

The outcome was assessed using one part of a seven-part PowerPoint project. Each part of the project had its own rubric and was assessed accordingly. Students could score a maximum of 25 points for this project part.

Met Standard of Success: Yes

100% of students (48/48) scored 75% or higher.

This meets the standard of success for this particular outcome. Students had to identify a target audience, share their project with other students on the course discussion board, and received feedback from other peers.

7. Based on your interpretation of the assessment results, describe the areas of strength in student achievement of this learning outcome.

Final Project: Students were able to identify an appropriate target audience for their project. They were able to demonstrate creativity and the skills identified by this outcome and for the first part of the project.

Based on the instructor feedback to students, one student omitted a footer and the remaining students who lost points either did not follow directions to post their presentation on the discussion board, or submitted their assignment too late for discussion. These are simple errors that can be corrected by carefully following instructions on the rubric.

Of the 62 enrolled students in the five terms being assessed, there were four student withdrawals. In addition, there were 10 incomplete projects, so only 48 were assessed.

4. Describe how students from all populations (day students on campus, DL, MM, evening, extension center sites, etc.) were included in the assessment based on your selection criteria.

The course is currently offered online only. Therefore, all enrolled during the noted semesters were included in the assessment.

5. Describe the process used to assess this outcome. Include a brief description of this tool and how it was scored.

The final project was a presentation created by the student broken down throughout the term into seven parts. Each part of the presentation required adding four slides to the presentation, increasing in difficulty each time, with a rubric given to the students to follow step by step.

In this assessment, the students used their own ideas and creativity, and it was assessed according to the rubric given--objectively by the instructor and in addition peer-reviewed, as each assignment was posted on a class discussion board that required feedback.

6. Briefly describe assessment results based on data collected for this outcome and tool during the course assessment. Discuss the extent to which students achieved this learning outcome and indicate whether the standard of success was met for this outcome and tool.

### Met Standard of Success: Yes

100% of students (48/48) scored 75% or higher, meeting the standard of success.

Based on the data, the students that completed the entire final project achieved an overall average score of 97.97%, far exceeding expectations. The average of the students that did not complete the entire project was 84.57%.

7. Based on your interpretation of the assessment results, describe the areas of strength in student achievement of this learning outcome.

Students did very well creating and designing their own presentations with their own ideas. They easily incorporated different graphics, media, and video into their presentations, and well exceeded expectations.

8. Based on your analysis of student performance, discuss the areas in which student achievement of this learning outcome could be improved. If student met standard of success, you may wish to identify your plans for continuous improvement.

Students met the standard of success. In the instances where points were lost, it was due to a lack of following all the instructions, i.e. posting to the discussion board and commenting on three other student presentations or missing a step in the rubric directions.

Plans for continuous improvement included adding a new assessment-a capstone project- recently incorporated into only the past two semesters.

The sample does not use data from the four withdrawals, as well as 10 students that completed only part of the final project. Therefore, the only students included in this outcome are those that have completed the entire project.

The course is currently only offered online. All students enrolled in online sections during the noted semesters were included in the assessment.

The final project presentation is divided into seven parts, each with its own rubric. In part 2 of the project, students produce speaker notes and in part seven produce handouts. These skills are previously covered in the course homework assignments before they are assessed in the final project.

## Met Standard of Success: Yes

100% of students (48/48) scored 75% or higher, meeting the standard of success.

Average scores for students completing of part 2 of the project, which produces speaker notes, was 97.57%. For part 7 of the project, which produces handouts, it was 98.83%.

7. Based on your interpretation of the assessment results, describe the areas of strength in student achievement of this learning outcome.

Students did very well producing this outcome with their presentations. In the cases where assessment points were lost, it was due to either the lack of following the directions, or not posting their results to the Internet link given to them.

Students met the standard of success for this outcome. I expect that full credit can be remedied by reminders on reading the instructions carefully and posting examples of what the final evaluations should look like. Therefore, in recent terms I have posted several examples of what each step of the final presentation project should look like, in addition to the rubric.

Of the 62 enrolled students in the five terms being assessed, there were four student withdrawals, and a total of 10 students that completed most of the final project but not all of it. Therefore, only 48 students completed the entire final project.

4. Describe how students from all populations (day students on campus, DL, MM, evening, extension center sites, etc.) were included in the assessment based on your selection criteria.

The course is currently only offered online. All students enrolled in online sections during the noted semesters were included in the assessment.

5. Describe the process used to assess this outcome. Include a brief description of this tool and how it was scored.

In this assessment, the students used their own ideas and creativity to create a 28-slide presentation (divided into seven parts of four slides each). It was assessed according to the rubric given for each part. Each rubric included points given for correct spelling and grammar, easy and clear fonts to read, and formatting that is visually appealing for clear and effective communication.

6. Briefly describe assessment results based on data collected for this outcome and tool during the course assessment. Discuss the extent to which students achieved this learning outcome and indicate whether the standard of success was met for this outcome and tool.

## Met Standard of Success: Yes

100% of students (48/48) scored 75% or higher, meeting the standard of success.

Based on the data, the students that completed the entire final project achieved an overall average score of 97.97% exceeding expectations. The average was lower for those students who did not complete the entire project, assessing 10 students-at 78.97%.

7. Based on your interpretation of the assessment results, describe the areas of strength in student achievement of this learning outcome.

Students did very well on clearly and convincingly creating their PowerPoint presentations.

Students met the standard of success for this outcome. Each rubric included points given for correct spelling and grammar, easy and clear fonts to read, and formatting that is visually appealing and consistent for clear and effective communication. Major point deductions here were only lost here when students neglected to complete the project.

Of the 62 enrolled students in the five terms being assessed, there were four student withdrawals. Also, three students did not take all of the required exams, but most of them. Therefore, I have included them in the 57 students for the unit exams assessment.

The course is currently only offered online. All students enrolled in online sections during the noted semesters were included in the assessment.

There are three unit exams and each unit exam has two parts. One part is completed in blackboard (objective questions) and the practical application part is completed in the SIMnet software. The SIMnet part requires creating a PowerPoint presentation with all of the required elements stated in its integrated rubric.

## Met Standard of Success: Yes

92.98% of students (53/57) scored 75% or higher on all three SIMnet exams.

Students completed the practical parts of the unit exams with average score of 94.61%. The score was lower for objective questions, with an average of 89.95%. Overall, this meets the standard of success for this outcome.

Students did very well creating and designing their own presentations with their own ideas. They easily incorporated different graphics, media, and video into their presentations, and well exceeded expectations.

Of the 62 enrolled students in the five terms being assessed, there were four student withdrawals.

Unit exam 3 requires students to save PowerPoints in different formats as well as create handouts.

## Met Standard of Success: Yes

98.25% of students (56/57) score 75% or higher.

Students that completed the practical parts of unit exam 3 had an overall average score of 95.13%. Only 10 students out of that 57 did not receive a perfect score of 40/40.

Students did very well producing this outcome with their presentations. In the cases where assessment points were lost, it was due to either the lack of following the directions, or not posting their results to the Internet link given to them.

Students met the standard of success for this outcome. I expect that full credit can be remedied by reminders on reading the instructions carefully and posting examples of what the final evaluations should look like. Therefore, in recent terms I have posted several examples of what each step of the final presentation project should look like, in addition to the rubric.

This course is currently meeting the needs of students. This is my second evaluation of this course, after total revision of the course in 2018. In addition, I have made a few changes that will be discussed below.

This course was revised from the ground up in the past. Students are currently using both Blackboard and SIMnet software. However, the previous assessment included the use of Gmetrix software in the exam assessment area. This has now been eliminated.

In addition, I have added a capstone assessment, only in the past two terms (Summer 2022, Winter 2023) per request of the department head. Students have done extremely well on this, with only 2 students not receiving a perfect score.

All students (100%) who completed the project scored a minimum of 19 of 25 (75%) points. This meets the standard of success for this outcome. Students were able to identify their target audience for the project. They also shared their plans with other students and received feedback via the Blackboard discussion board.

There are 3 unit exams and each unit exam has 3 parts. One part is completed in blackboard (objective questions) one part is completed in GMetrix software (objective questions) and one practical part of the exam in SIMnet software- the SIMnet part requires creating a PowerPoint presentation with all of the required elements stated in the rubric.

# Met Standard of Success: Yes

97% of students completed the practical parts of the unit exams with a score of 100%. One student received a 25/40 and another received a 35/40 and the remaining received a 40/40. This meets the standard of success for this outcome.

Students did very well creating and designing their own presentations with their own ideas. They easily incorporated different graphics, media, and video into their presentations, and well exceeded expectations.

In this assessment, the students used their own ideas and creativity to create a 28 slide presentation (divided into 7 parts of 4 slides each). It was assessed according to the rubric given. Each rubric included points given for correct spelling and grammar, easy and clear fonts to read, and formatting that is visually appealing for clear and effective communication.

### Met Standard of Success: Yes

Based on the data, the students that completed the entire final project achieved an average score of 98.35% far exceeding expectations. The average was slightly lower when adding in those students who did not complete the entire project, assessing 38 students-- at 98.1%. All students (100%) who completed the project scored a minimum of 21 of 25 (84%) points.

Students did very well on clearly and convincingly creating their PowerPoint presentations. They far exceeded expectations.
