Yes
This course was assessed in Winter 2019.

Outcome 1: 38 of 39 (97%) of students scored 100% on the exam and met the standard of success for the course.

Outcome 2: 100% of students met the standard of success on the outcome-related activities.

Outcome 3: This outcome was not assessed due to inclement weather conditions.

3. Briefly describe the Action Plan/Intended Changes from the previous report(s), when and how changes were implemented.

Students performed very well on the essay questions, applying multiple theories to classroom or student related scenarios. Not only were they able to associate the details of the theory with the theorist, but they were able to apply the theories appropriately.

Summary Data includes all of the following:

- 1. The number of students enrolled in the course: 62 students total in both Winter 2023 online classes.
- 2. The number of students assessed: 45 students assessed
- 3. The percentage of students assessed: 72.58% of students were assessed. Some students withdrew from the course or did not complete the Lesson Plan assignment.

4. Describe how students from all populations (day students on campus, DL, MM, evening, extension center sites, etc.) were included in the assessment based on your selection criteria.

There were three sections offered; two sections were offered as DL and one section

was offered in traditional classroom setting.

The PSY 220 traditional course was taught by a part-timer and data was not collected for this assessment. However, I have a plan in place to include all sections in future assessments.

5. Describe the process used to assess this outcome. Include a brief description of this tool and how it was scored.

Outcome 1 was assessed using two essay questions in a Lesson Plan Worksheet. Each question was worth 10 points. Students' responses were scored using a rubric.

While I do believe that this lesson plan worksheet assignment is a superior assessment tool, I will be using the multiple-choice questions from now on. This is for simplicity and to respect instructor autonomy (it's much easier to ask other instructor's to give a short quiz rather than a lesson plan worksheet).

6. Briefly describe assessment results based on data collected for this outcome and tool during the course assessment. Discuss the extent to which students achieved this learning outcome and indicate whether the standard of success was met for this outcome and tool.

### Met Standard of Success: Yes

42/45 (93.33%) of students scored 70% or higher on the outcome-related questions.

This meets the standard of success and shows that students were able to recognize educational and functional considerations and implications when dealing with exceptional students.

7. Based on your interpretation of the assessment results, describe the areas of strength in student achievement of this learning outcome.

The students are given a plethora of data and essay test scenarios applying each theory to various age groups. Students were able to apply this information to the lesson plan based on the students' grade level.

8. Based on your analysis of student performance, discuss the areas in which student achievement of this learning outcome could be improved. If student met standard of success, you may wish to identify your plans for continuous improvement.

The students need access to a more diverse group of educational theorists. The traditional theorists are seven white males and one black male. There are no female theorists presented to students in this course. Additionally, there should be a more culturally and ethnically diverse group of theorists to reflect and address the needs of a changing society.

Three PSY 220 classes were offered; two DL courses and one traditional course.

The PSY 220 traditional course was taught by a part-timer and data was not collected for this assessment. However, I have a plan in place to include all sections in future assessments.

Some students withdrew from the course or did not complete the lesson plan Assignment.

5. Describe the process used to assess this outcome. Include a brief description of this tool and how it was scored.

For Outcome 2, students created a lesson plan based on the grade level / age of the student.

In this lesson plan, students were required to create multiple ways of teaching a concept based on a variety of learning styles such as visual, auditory, hands on, etc.

Student's responses were reviewed based on three criteria and were given a 1 if they met the criteria or a 0 if they did not. Students' responses varied greatly, but all students provided correct educational strategies.

While I do believe that this lesson plan assignment is a superior assessment tool, I will be using the multiple-choice questions from now on.

6. Briefly describe assessment results based on data collected for this outcome and tool during the course assessment. Discuss the extent to which students achieved this learning outcome and indicate whether the standard of success was met for this outcome and tool.

# Met Standard of Success: Yes

38 of 38 (100%) students scored a 7 or above in completing this section of the lesson plan. This meets the standard of success.

7. Based on your interpretation of the assessment results, describe the areas of strength in student achievement of this learning outcome.

Based on the information provided to students this information was adequately addressed.

8. Based on your analysis of student performance, discuss the areas in which student achievement of this learning outcome could be improved. If student met standard of success, you may wish to identify your plans for continuous improvement.

This course needs to include information on how online learning and teaching has impacted motivation to learn when so much information is accessible online. How do we modify teaching and learning to reflect the technological advances in society? Students have access to answers by doing very little research online. Is this a modified version of learning and how can we as educators incorporate these tools into our courses to verify the students' ability to apply this data when needed?

Additionally, this course needs to incorporate the educational needs of transgender and non-binary students because of the impact hormones have on psychological health and well-being that impacts learning.

The traditional PSY 220 class was taught by a part timer and data was not collected or assessed. However, I have a plan in place to include all sections in future assessments.

All Winter 2023 online classes were assessed.

5. Describe the process used to assess this outcome. Include a brief description of this tool and how it was scored.

The students were required to complete a comprehensive lesson plan applying the various theories covered in class, including biological and social age development and various methods of learning styles that include visual, hands on, auditory, left and right brain hemisphere dominance, as well as the 8 types of intelligence.

While I do believe that this lesson plan assignment is a superior assessment tool, I will be using the multiple-choice questions from now on.

6. Briefly describe assessment results based on data collected for this outcome and tool during the course assessment. Discuss the extent to which students achieved this learning outcome and indicate whether the standard of success was met for this outcome and tool.

#### Met Standard of Success: Yes

44/49 (89.8%) of students met the standard of success in completing the lesson plan. The lesson plan is an accumulation of previous modules, exams, and exercises. Additionally, students are required to critique 3 to 5 online lesson plans.

7. Based on your interpretation of the assessment results, describe the areas of strength in student achievement of this learning outcome.

89.8% of students met the standard of success, as previously stated students were given various opportunities to apply the information needed to successfully complete the lesson, including critiquing 3 - 5 lesson plans online.

The lesson plans are designed for traditional classroom styles of teaching and learning. The new lesson plan should include a section on how to teach students online, as well as in a virtual, and hybrid setting. Most schools have incorporated online / distance learning to their curriculum.

The course assessment previous changes did not note any changes to be incorporated due to students' ability to apply theoretical data appropriately. The previous assessment was prior to covid which has had a tremendous impact on the availability of online learning and teaching.

This course is meeting the needs of the students based on its original inception, prior to online /distance learning and a growing global economy of a more culturally diverse society. Data for this outcome was not available for students in the face-to-face class due to inclement weather. Thirty-nine students from the online sections took exam 2 which addressed this outcome.

Only online students were assessed. Data for the face-to-face section was not available.

Exam 2 contained four (4) essay questions related to the human development theories. Essays were worth 50 points each for a total of 200 points.

#### Met Standard of Success: Yes

38 of 39 (97%) students scored 100% on the exam and met the standard of success for this tool. The other student scored 160 points, which still meets the standard of

success. Students did very well in recognizing and applying various learning theories.

Students performed very well on the essay questions, applying multiple theories to classroom or student-related scenarios. Not only were they able to associate the details of the theory with the theorist, but they were also able to apply the theories appropriately.

For the face-to-face class, exam 1 was used. For the online courses, we used a combination of outcome-related exam questions and course assignments.

### Met Standard of Success: Yes

100% of students met the standard of success by exceeding a score of 70% on the outcome related activities.

Students were able to recognize and apply their knowledge of the biology of the brain and how that affects one's ability to learn. Furthermore, students were more successful because they had the latitude to demonstrate their understanding in a way that fits best with their learning style.

Seventy percent (70%) of students must obtain a 2/acceptable or 3/superior for outcomes 1 & 2; a score of 100 or higher for outcome 3.

3. Briefly describe assessment results based on data collected during the course assessment. Seventy-two percent of students scored 70% or higher for all outcomes assessed.

4. Describe the areas of strength and weakness in students' achievement of the learning outcomes shown in the assessment results. (This should be an interpretation of the assessment results described above and a thoughtful analysis of student performance.)

Strengths: The quality of lesson plans written by students in the Psychology 220 Distance learning courses are superior to the lesson plans created by students in the traditional classroom setting in the previous years. Assessor expected to see the opposite results. Students taking the online psychology 220 class were required to search online for lesson plans that they thought were excellent, explain their assessment, and post it to Blackboard discussion for other students in the online course to comment on them. This assignment was not required in the traditional classroom. Giving the students the opportunity to see how educators design lesson plans from a multitude of backgrounds has enriched their ability to apply the concepts covered in the psychology 220 course.

Weaknesses: Students enrolled in the traditional classroom setting will be required to search online for lesson plans written by educators in elementary and secondary education to enhance their ability to write more in-depth and creative lesson plans. The comparison between the student's performance in the traditional classroom verses the distance learning psychology 220 is a subjective observation that is not written as an objective measure, yet an unexpected outcome.

### III. Changes influenced by assessment results

1. If weaknesses were found (see above) or students did not meet expectations, describe the action that will be taken to address these weaknesses. (If students met all expectations, describe your plan for continuous improvement.)

The assessor assumed that the traditional classroom setting offered a superior learning experience for students enrolled in psychology 220. However, the assessor discovered that requiring students to review lesson plans written by a variety of elementary and secondary teachers online increased the quality of work submitted by the students.
